Constitution: New Articles and Bylaw

The OVWSG has a new Constitution and a reorganized Board of Directors.

On October 11, 2013, Corporations Canada continued the existence of the OVWSG under the new *Canada Not-for-profit Corporations Act* (CNCA) and accepted the governance documents that were approved by our members at the Annual General Meeting on June 3rd, 2013. The new Constitution consists of Articles of Continuance (Form 4031) and Bylaw No. 1 attached to this newsletter.

The new Articles and Bylaw:

The CNCA makes mandatory many of the matters that were already in the 2008 OVWSG Constitution and Bylaws. While specified in the Act, most of these matters have been set out in the Articles (aka Form 4031) and Bylaw No.1 so that our members do not need to read the Act to understand the Guild's governance structure and rules.

The new Articles and Bylaws also reflect the Resolutions approved by the members on June 3, 2013 that:

- restricted the borrowing powers of the Board and
- waived an annual review audit by a public accountant of the Guild's finances which would otherwise be required because the OVWSG receives more than \$10,000 in public money and has annual revenues of less than \$50,000.

The new Articles and Bylaws include changes that should assist the Guild's application for tax-exempt status under the *Income Tax Act*. Both the consolidation of the three classes of members into one class, and the new wording of the purpose of the Guild were made to meet the requirements of the Canada Revenue Agency for charitable status. Applying for that status is the next step in the Guild's strategic plan.

The Board:

The CNCA strengthens non-profit corporations by adding two required positions to the Board: a Chair and Vice-chair. The Chair of the Board and Vice Chair are non-operational positions – that is, their occupants are not responsible for the day to day running of the Guild. That responsibility belongs to the operational Board members: the President, Secretary, Treasurer and such other positions added by resolution of the Board. Rather, the Chair and Vice Chair supervise the operational Board members. They set the strategic direction and objectives of the Guild and approve policies that carry out the objects of the Guild in accordance with principles of good governance. The Chair and Vice-chair also have an obligation to look out for, and protect, the interests of the members where affected by the operational actions.

As approved by in members at the AGM on June 3rd 2013, the reorganized Board will hold office until the next AGM in May 2014. The Board now consists of:

At the Executive Meeting on 22 October 2013, the Studio Manager, Ann Sunahara <u>studio@ovwsg.com</u>, and the Workshop Coordinator, Elizabeth Watt <u>workshops@ovwsg.com</u>, were added to the Board by Resolution.

Timing and Terms of Office

The new Act allows greater flexibility in the timing and terms of office for the members of the Board. It permits terms of up to 3 years and the terms of different officers can be staggered so only some are elected in any given year. The members of the Guild will need to determine the timing of the elections for, and the length of the terms of, each Board member before the next AGM in May 2014.

Business Report:

Presentation

• Jean Sharp and Aurora Richard presented a thank you and gift on behalf of the OVWSG to Ann Sunahara for her hard work and commitment to the design and planning of the studio and move.

• Ann thanked the guild and various people's hard work to assist her.

Guest Speaker Presentation

Jean-Maurice Côté, the past president of the "Artisans et Artiscenes de Ceintures Fléché du Québec", talked about the early beginnings of the ceintures fléché and various types of sashes made throughout Canadian history. One sash can take him 5 months to make, working on one strand of wool yarn / hour. Each strand can be about 5 metres long, and each sash can have roughly 200 strands.

Jean-Maurice brought several different sashes, including his early ones, before he joined the Artisans Association. He charges from \$30.00, up to \$3000.00 per sash, depending on the amount of work involved.

M. Côté will be demonstrating his skill at the Experimental Farm, during the Sheep shearing event on Sunday next May.

Note: Judy Kavanagh offers a 1-day class on making the ceintures fléché.

Any property remaining on liquidation after the discharge of any liabilities of the Corporation, other than property that has been transferred to the Corporation subject to the condition that it be returned on dissolution of the Corporation, shall be transferred to one (1) or more qualified donees within the meaning of subsection 248(1) of the Income Tax Act.

Annex A

The purposes of the Guild are, with respect to hand-weaving, hand-spinning and other related fibre arts,

a) to encourage its membership to achieve a high aesthetic standard and technical expertise; and

b) to promote and foster the knowledge of, interest in, and appreciation for historic and contemporary weaving, spinning, and their related fibre arts by:

(i) educating the public and fibre artists through courses, seminars, demonstrations, public events and workshops;

(ii) maintaining and operating an educational training centre with a resource library of media pertaining to those fibre-arts and their ancillary techniques; and

(iii) staging exhibitions and other public events that promote those fibre-arts.

Annex B

1) The activities of the corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation must be used in furtherance of its purposes.

2) Notwithstanding the *Canada Not-for-Profit Corporations Act*, the directors of the corporation shall not borrow money on the credit of the corporation or grant security on the property of the corporation or otherwise create a debt obligation for the corporation other than an obligation to pay rent for the space or spaces in which the activities of the corporation are carried on.

3) The members shall elect the directors at the annual general meeting.

4) The directors may appoint one or more directors, who shall hold office for a term expiring not later than the close of the next annual general meeting of members, but the total number of directors so appointed may not exceed one-third of the number of directors elected at the previous annual general meeting of its members.
