Most of Heartwood House is still under construction, so you need to enter the building by the western-most front door (under the UNITARIAN FELLOWSHIP sign). This is the former front entrance to the Giant Tiger store that used to occupy the building. Our Studio is on the front near the west end of the complex and opens into the UF lobby.

# Tale of a Move

When 153 Chapel Street was first sold to a developer two years ago, the OVWSG chose to stay with the other charities under the Heartwood House (HH) umbrella and to move to another rented property. However, the brave people who run HH soon realized that if we all moved to a rented property, we would have to move again in 5 to 10 years when that landlord was bought out by a developer. And so a search began for a property to buy. In the end, the HH found a small plaza at 400 - 410 McArthur Ave, near St. Laurent Blvd. The complex had over 15000 sq ft including an empty former Giant Tiger store, three retail businesses and several apartments on the second story.

Thus began a long and complicated process in which HH found financing, bought the property and began to design and contract for the renovations necessary to make it a suitable home for the 18 charities under its umbrella. The purchase took several months longer than the initial closing date -- normal in commercial transactions -- 4Té designs came forward to offer its services, and to cut costs, much of the work was done by the intern, Michelle Goodison. RND construction committed to carry out the renovations. Then the process of developing the plans and getting the approval of the City's planning department dragged on for several months as the City sought changes to bring the project to a high standard of fire preventiveness and to meet the requirements for improvements like elevators and for completely new HVAC, plumbing and electrical systems. The HH Board and its fundraising committee -- which included our Marianne Heggtveit -- worked long and hard to bring it to fruition.

The OVWSG space is located in Phase 1 of the renovation -- in the former Giant Tiger store -- along, with the other larger organizations, ALSO, ELTOC, HH/OC Transpo Lost and Found and the Unitarian Fellowship (which bought 12.5% of the building). Phase 1 is ready for occupation. We are the first to move into the new space. Phases 2 and 3 are still in development. They have been delayed by the building of the elevator and the requirements of the City for everything to be done at once rather than in stages. The rest of HH will move into Phase 2 and 3 by the end of October.

The OVWSG's journey to the move is equally long and complicated. It begins in May of 2012 when we optimistically contracted with a mover for a move scheduled for the fall of 2012. By July, the closing date for the sale had been moved to the fall of 2012 and completion to the spring of 2013, so Kathleen Schwass, Ruth Cooper and Ann Sunahara took an inventory and began to seriously to plan. First a committee composed of Aurora Richard, Marianne Heggtveit, Kathleen Schwass, Elizabeth Watt, Jan Scott, Ruth Cooper, Cindy O'Gorman, Shirley Browsky, Francesca Overend and Ann Sunahara decided the Principles to guide the move and the requirements for the studio. Then we set a budget and began to research possible purchases to see what could be accomplished within our budget, including the kitchen, tables, whiteboards, equipment cabinets, cabinets for magazines/journals, office furniture and storage, a kitchen island, spinning storage, carts for demos, dyeing and fibre processing. Wish lists were compiled and design specifications were sent to the designer who adjusted them a bit to fit new codes. The board approved a kitchen design and a colour scheme

in late December 2012. In March we were offered an enlarged storeroom in Phase 2 and a small storeroom in Phase 1. In anticipation of a completion date in July, we packed the library on June 22. But the move date kept shifting as we waited for the installation of the kitchen and flooring. The kitchen was bought and the installation completed in late July under Kathleen Schwass' supervision who also packed up the kitchen. The spinning equipment was packed and the wheels were sent off-site for

safe-keeping in early August. The delay meant that our carefully planned staged move spread over two weeks had to be compressed into a few days with 3.5 tons of our possessions being moved in 12 hours by two professional movers on August 13.

Unpacking has taken another 3 weeks as we work mostly on weekends so as not to interfere with the tradesmen on site. Jan Scott and her team, including Alison James and Ann McElroy, have put in dozens of hours of work to set up the library. Kathleen Schwass and Francesca Overend set up the kitchen. Anne Jackson and Mick, Samantha Richardson Van Noy and her mother Carole, and Cindy O'Gorman and Ann Sunahara assembled the OHS cabinets for Laurie Harkin-Chaisson to fill with the Studies. Marianne Heggtveit and Ann Sunahara tried to organize the equipment and the materials used by the Exhibition and Sale. And on August 31, David and Ann Sunahara, Francesca Overend, Myriam Ferland, Shirley Browski, Kathleen Schwass and Laurie Harkin-Chaisson reconstructed the looms and tried to them in order. The office area is being delayed until the second 100+ square-foot storeroom is ready in October.

But we now have a beautiful new home. It still looks crowded because we are still waiting for, the completion of another 100+ square-foot storeroom which should be ready in October. Anything that looks out of place is because its place is in the missing storeroom. Come and check it out on September 9th, 2013.
